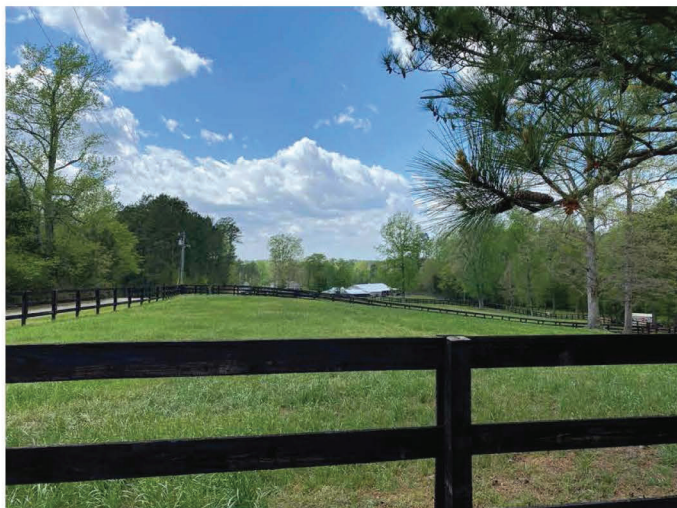
**Class Specs:** **Walk/Trot and Wee Poles** open to all beginner riders. **Greenie Crossrails** open to beginner horses and ponies. **Beginner Crossrails** open to riders in first two years of showing over fences. **Hopeful Hunter and Open Hunter** open to all riders. **Triangle Hunter** open to non-professional riders. Pony Hunter open to junior riders. **Short Stirrup** open to riders 12 and under. **Long Stirrup** open to riders 13 and over, both in first 2 years of showing. Champion and Reserve to be awarded for each division.

CHAPTER 99E NORTH CAROLINA GENERAL STATUTES**

Horse Show Participant (or Parent/Guardian of Participant if a minor) is aware of the many obvious and non-obvious risks associated with a horse show and does hereby *release and hold harmless Triangle Farms, Inc. and its affiliates, including its shareholders, agents, employees, officers, directors, representatives, assigns, affiliated organizations (whether nonprofit or for profit), boarders, exhibitors, sponsors, students, lessors, lessees, insurers and others acting on behalf of any of them (collectively, "Triangle Farms") from all claims, demands, causes of action and legal liability related to the Horse Show Participant's participation in or presence during the Horse Show, whether the same be known or unknown, anticipated or unanticipated, foreseeable or unforeseeable, and even if such are the result of the negligence and/or acts or omissions of Triangle Farms or other Horse Show Participants or other individuals or animals present during the Horse Show.*

Horse Show Participant (or Parent/Guardian of Participant if a minor) further agrees to (a) waive all claims which may otherwise arise from an injury to a Horse Show Participant or other individual or animal associated with Horse Show Participant while using or being present at the Horse Show, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection (including, but not limited to, the novel coronavirus known as COVID-19 and other rhino or coronaviruses as well as rabies, hepatitis, pneumonia and meningitis-causing viruses, among others; bacteria commonly known as tetanus, Salmonella, E.
